# What will the weather be like?

Temperatures in Alaska vary based on the time of year and the port of city you are visiting. The weather off the ship is unpredictable but the average daily high in July is 60-80 degrees Fahrenheit.

Most days are very comfortable, but it's important to be prepared for both cold and warm weather. Pack wisely and dress in layers and you should be able to enjoy Alaska whatever the weather conditions may be.

# Will vaccinations be required to travel to this part of the world?

# I'm traveling by myself. Can you assign me a roommate?

We have decided not to take on the responsibility of pairing up roommates.

If you are unable to find a roommate on your own, you will be required to pay the single occupancy rate.

## What are the bedding options?

Two twins or one queen (two twins pushed together).

Bunks come out of the ceiling or wall for  $3^{rd}/4^{th}$  guests in standard staterooms. A pullout sofa would be substituted for the bunks in mini-suites & suites.

## What if I am a past cruiser with Princess?

If you provide your Captain's Circle Number on your deposit form, we will apply that number to the new cruise reservation as well as check your eligibility for any past cruiser specials or promotions.

## Is child care available on the ship?

Childcare is available for children ages 3-17 (fees may apply).

#### What if I have the tendency to get seasick?

We recommend requesting a stateroom as mid-ship as possible on an upper deck.

Over the counter medications and/or seasickness patches are also recommended.

## What is included in the cruise price?

Selected accommodations on board the ship. All meals and entertainment on board (Note: Specialty restaurants require cover charges). All mandatory government fees and taxes. Live continuing education hours.

## What is NOT included in the cruise price?

Airfare. Pre-paid gratuities. Airport/pier transfers. Beverages other than water, coffee, tea, etc. at mealtime. Items of personal nature such as phone calls, dry cleaning, etc. Optional tours and excursions. Travel insurance.

# What airport should I be flying in/out of?

You can fly in/out of Seattle-Tacoma International Airport.

#### How far is the pier from the airport?

Pier 91 (Smith Cove Terminal) is located 17 miles north of Seattle-Tacoma International Airport. Travel time from the airport to the pier is approximately 45 minutes, subject to traffic.

## How much are airport/pier transfers?

Transfers between the Seattle-Tacoma Airport and Pier 91 are \$24/person each way. Flights must arrive no later than 1:00pm on July 23<sup>rd</sup> and depart no earlier than 11:30am on July 30<sup>th</sup>.

#### Is my passport number required in order to submit the deposit form?

Yes.

# How much are gratuities?

Gratuities of \$13.95 per person per day for mini-suites and suites, and \$12.95 per person per day in all other stateroom categories will automatically be added to your shipboard account. A 15% gratuity is added to bar charges and dining room wine accounts.

These gratuities can be prepaid up to one week prior to departure.

# What is the cancellation policy?

#### Seminar Fees:

If cancelled within 2 weeks of registering, a full refund will be issued. After the 2 week period, the refund of the seminar fees (\$300) will be in the form of a gift card.

## Prince Cruise Line – Cruise Deposit:

After the 2 week period, but before final payment date (May 5, 2017), the balance of the deposit (minus the seminar fees) will be refunded in the form of a check from the travel agency. If cancelled after the final payment date, cancellation penalties will apply.

If cancelled or refunded, the Early Bird Free Tuition Coupon would be invalid.
